# Agreement

Maple Lane Siberian Huskies guarantees that the above named puppy is in good health to the best of our knowledge and has been inoculated and wormed as set forth below. This health guarantee will be honored for up to three (3) days from the date of purchase. The purchaser is strongly urged to have the puppy examined by a licensed veterinarian within the guarantee period. Should the examining veterinarian find the puppy to have any life-threatening disease, a full refund will be provided. The puppy must be returned within the guarantee period.

The puppy is guaranteed to be free of any major hereditary health defects for a period of two (2) years from the date of purchase. Should a problem arise, an examination will be performed by a mutually selected veterinarian at the purchaser's expense. The report should be forwarded to Maple Lane Siberian Huskies. If the problem is found to be hereditary in nature, a replacement will be made.

The purchaser agrees to have the puppy spayed or neutered at 9-12 months of age in order for this agreement to be honored.

It is further understood that Maple Lane Siberian Huskies assumes no responsibility for the puppy after it leaves the premises for any reason other than those which are listed above. In cases of abuse, misuse, or neglect, this dog can and will be legally confiscated. The purchaser will pay recovery costs of not less than \$50.00 (fifty dollars) and no replacement will be made.

This agreement is non-transferable. No other agreement will be honored.
